All papers included in this CV are indexed in the ISI Web of Science and/or in SJR-SCImago Journal Rank (Scopus). Two of which are Q1: *Urban Geography* in the area of Geography (Social Sciences Index (2018)- with an impact of **3,149**. *Journal of Planning Education and Research* is also ranked as Q1 with a JCR impact of **2,742**. Both journals are also Q1 in SJR-SCImago index in, both, the areas of Geography, Planning and Development and Urban Studies.

In relation to the individual impact of the publications, according to Google Scholar (16/07/2020), the H index score is 19 (33 i10). For the past five years, index rankings are at 15 and 18 respectively. Total citations are **1147**, 616 in the past five years. The individual impact of papers linked to the subject is number 10 (2008) **124**; 8 (2010) **56**; 7 (2013), **32**; 5(2016), **33**; 9(2009), **28** and 6 (2015), **20**.

Tenured Professor of Human Geography at Pablo de Olavide University. PhD in Geography at the University of Seville and Master of City Planning at the University of Pennsylvania during a two year Fulbright/Banco de Bilbao fellowship. Professor at the universities of Seville and Huelva and, since 2002, Pablo de Olavide University.

Research activities include 36 research projects and contracts, 16 of which were competitive as Lead Researcher, related to urban and metropolitan processes, urban and regional planning, and Territorial Development.

The body of scholarly work covers a large research trajectory in relation to urban and metropolitan structures and processes, the most notable being four consecutive interdisciplinary coordinated projects funded by The R&D National Plan, from which the present proposal is a continuation. Apart the range and impacts of publications included in this research line, both at scientific and social and institutional level, another product is his active participation in Research Networks both at national (RETURBAN) and European (METROPOLE) level.

Important research and contract projects have been undertaken in the area of regional planning and development, including three interdisciplinary projects, two of which have an international scope on the topic of territory, landscape, and heritage. Linked to these, I have developed as Head Professor in

international cooperation projects and networks with Latin American countries in both research and teaching matters.

My publication output covers more than 140 references in different formats (papers, books, conference abstracts, etc.), among which 31 journal papers (23 of them JCR/SJR) have been written in Spanish, English and French. I have edited two scientific books, one about Spanish metropolitan areas published by Cathedra-Thomson Reuters, while the second concerned Territorial Heritage and was published by Taylor and Francis.

I have broad experience in the field of the development and transference of research results. As a planner, I worked for six years (1983-1988) at the Metropolitan Studies Institute of the Regional Government of Andalucía on subjects related to metropolitan planning and management and I have participated in various Master Plans (Seville, Alcalá de Guadaíra, etc.) and Regional and subregional Territorial Plans (Andalucía and Seville), Strategic Plans (Málaga, Costa del Sol), and Urban Agendas (Andalucía). Moreover, I have produced many studies and reports for public administrations on subjects such as urban systems and processes, industrial and service location and organisation, amongst others. At the present time I am a permanent member of the Andalusia Territorial Observatory and Observatory of Local Government.

Tasks within the university and attendant academic responsibilities include an elected post as Dean of the Faculty of Humanities (University of Huelva) and Chairman of the departments of Geography and History in Huelva and Pablo de Olavide. I have been elected a member of the Spanish Geographers Association and Geographic International Union. I am a member of the editorial boards of four scientific journals, a reviewer for more than thirty national and international journals, and an evaluator for MINECO, ANEP, and the AGENCAT.
